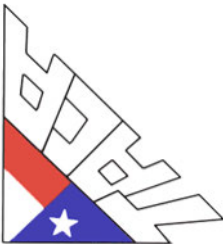

## Refund & Cancellation Policy

- A. A full refund of fees paid will be authorized when a written request for cancellation of conference or program is received by the TACA Secretariat at least 31 days prior to the scheduled start of the program.
- B. A refund of 70% of the fees paid will be authorized when a written request for cancellation of conference or program is received by the TACA Secretariat more than 5 days but less than 31 days prior to the scheduled start of the program.
- C. A refund of 30% of the fees paid will be authorized when a written request for cancellation of conference or program is received by the TACA Secretariat less than 5 days prior to the scheduled start of the program.

- E. Substitutions may be made for persons that are unable to attend. Advance notice is requested.
- F. The TACA Board may make exceptions to the refund policy in the event of an emergency that prevents the participant from attending as scheduled.
