Refund & Cancellation Policy

- A. A full refund of fees paid will be authorized when a written request for cancellation of conference or program is received by the TACA Secretariat at least 31 days prior to the scheduled start of the program.
- B. A refund of 70% of the fees paid will be authorized when a written request for cancellation of conference or program is received by the TACA Secretariat more than 5 days but less than 31 days prior to the scheduled start of the program.
- C. A refund of 30% of the fees paid will be authorized when a written request for cancellation of conference or program is received by the TACA Secretariat less than 5 days prior to the scheduled start of the program.
- D. No refund will be given for participants that do not attend the program and no advance notice of cancellation is received.
- E. If no cancellation in writing is received by the TACA Secretariat and no payment has been received 5 day prior to scheduled start of the program. You will be charged 70% of the cost of registration fee.
- F. Substitutions may be made for persons that are unable to attend. Advance notice is requested.
- G. The TACA Board may make exceptions to the refund policy in the event of an emergency that prevents the participant from attending as scheduled.
